**Stewart Capital Mid Cap Fund Recognized on the NASDAQ
– New Ticker Symbol (SCMFX) Confirmed Six Months After Launch –**

Indiana, Pennsylvania – The **Stewart Capital Mid Cap Fund**, offered by Stewart Capital Advisors, LLC, a subsidiary of S&T Bank, has received the NASDAQ ticker symbol (SCMFX) six months after its initial launch. The Fund will trade under the new symbol immediately, allowing the investing community to monitor the Fund.

“The ticker symbol enables the Fund to be listed on NASDAQ’s data feed, which is distributed to Morningstar and Reuters and allows investors a means to monitor the Fund through sources such as Yahoo! Finance and MSN Money.”

The Stewart Capital Mid Cap Fund, a diversified, open-end fund, that launched nationally on December 29, 2006, has grown to more than \$10 million in assets. The Fund seeks long-term capital appreciation by investing primarily in equity securities of U.S. companies with a focus on a relatively small number of intensively researched companies whose market caps fall within the market capitalization range of companies within the Russell Midcap Index. Because the Fund invests in a limited number of securities it may present greater risk than a more broadly diversified portfolio.
